The general consensus was that it would be prudent not to pursue an increase in funding in the current financial climate. The AONB Board continued to support an essential statutory function of local authorities for which they provided core funding. In the longer term, the Surrey Hills Family would play an increasingly important funding role in achieving the wider project work of the AONB. It was agreed that the Statutory Members Group would be reviewing the constitution and funding formulae in 2018.	SMG
