



National Landscapes


- Surrey Hills was second AONB designated in 1958
- Now one of 34 AONBs covering 18% of England
- Equivalent landscape status to the 10 National Parks

- Cultural Heritage





The Glover Review

Review of Designated Landscapes (National Parks and AONBs):

Making a case for more

"Not all factors or indicators have to be present across a landscape. The weight and relative importance given to different factors depend on the geographic context."

There is a greater opportunity to:

- `engage people with nature, most likely focused on peri-urban and urban areas' **Natural England Board**, **March 2021**.
- respond to the Climate and Biodiversity Emergency
- have a more progressive and consistent approach to identifying the boundary based on:

major roads

railway lines urban fringe/ Green Belt





Criteria weighting

Greater weight should be applied to:

Scenic quality

of views from the urban edge and major roads

Natural heritage

to be bigger, better managed and better connected

Historic heritage of parkland contributing to the Surrey Hills, in particular recognising parkland golf courses

Criteria weighting

Less weight should be applied to:

Relative tranquillity

given the location of Surrey and being within London's Green Belt

Relative wilderness but recognising the value of large-scale uninterrupted views from the urban fringe

Landscape quality of farmland but acknowledge the role of golf courses and horse pasture in managing beautiful landscapes.























- NE assessment of responses by end of November 2023.
- Further 8-12 week consultation for any additional AONB land proposed
