# **Management Plan (2025 – 2030)**

# Purpose of the report:

To outline the programme for developing a new Management Plan for 2025 - 2030

#### **Recommendations:**

Members are asked to

- 1. Note the guidance for National Landscapes in England
- 2. Agree the outline programme for developing a new Management Plan for the Surrey Hills National Landscape

#### 1. Introduction

- 1.1 The statutory Management Plan is the primary document through which the purposes of the National Landscape can be achieved. It sets out the ambition, strategy, and guidance to achieve the purposes of the designation and, where possible in doing so, enhancing people's quality of life.
- 1.2 The current Surrey Hills AONB Management Plan has been adopted as a statutory document that sets out the vision and policy framework for the period 2020 to 2025. It has been adopted by all the constituent local authorities. A new Management Plan for the Surrey Hills National Landscape will need to be adopted for the period 2025 2030.

# 2. Natural England Guidance

2.1 Natural England is in the process of producing guidance on the management planning process for Protected Landscapes; National Parks and National Landscapes, designated as Areas of Outstanding Natural Beauty. The guidance is non-statutory but will set out a framework for producing and delivering a consistent suite of statutory National Landscape Management Plans across England, noting that individual National Landscapes need to tailor their Management Plan review and management planning activity to suit the resources available and other local circumstances.

2.2 Producing the Management Plan is both an opportunity and an obligation for National Landscapes. Effective management planning enables those involved with the National Landscape to set the agenda for change and manage change effectively. 'Management planning' is how Plans are produced, reviewed, and delivered by

- bringing people together, build relationships and grow commitment
- building consensus around a vision for the future

• establishing a Management Plan around which joint action can happen and resources can be secured


2.3. The Management Plans will need to reflect the recommendations highlighted by the Landscapes Review.

• A requirement for new Management Plans to be spatial in their consideration of the Landscape, aligning with the new Local Nature Recovery Strategies

• Each Management Plan will need to identify targets for Nature, Climate, People and Place, aligning with a new Outcomes and Targets Framework

• Guidance will include Climate Change Adaptation Plans, which are now mandatory as set out in the Third National Adaptation Programme published in July.

2.4. The draft Natural England guidance sets out the following Management Plan process.



#### 3. Surrey Hills Management Plan process

3.1 We are still awaiting NE guidance, but some of the proposed principles and activities in developing the Surrey Hills National Landscape Management Plan are:

- **Evidence.** An early stage will be to prepare the evidence base in a State of the Surrey Hills National Landscape report. Through the evidence gathering, there is an opportunity to consider using the platform created for the boundary review. This will be subject to costs and team capacity.
- Historic research celebrating the 1949 Act and Surrey Hills designation. 2024 is the 75<sup>th</sup> anniversary of the 1949 National Park and Access to the Countryside Act. This was seminal post-war legislation, along with the 1946 NHS Act, which acknowledged the importance of safeguarding the countryside for the nation's health and well-being. This provides an opportunity to research what the Surrey Hills were like when the Surrey Hills was designated in the 1950s.
- **The Surrey Hills Jigsaw Project** will be 25 years old in 2025. This was a project working with all the parish councils and community groups that identified the special qualities of the Surrey Hills. Reviewing the Jigsaw Project is an opportunity to engage resident stakeholders to look back and consider again special qualities, what has changed identifying where the natural beauty and special qualities are resilient and what is likely to change (and therefore needs to be monitored every 5 years) because of climate change etc

- A 75-year vision. After looking back at how the landscape has changed, to consider what it is like now, there is the opportunity to engage people to think what it will be like in the next 75 years, a 22<sup>nd</sup> Century vision (2025 2100). Opportunities are being researched with partners like Surrey University to use virtual reality `metaverse' to help inform and visualise what the landscapes and habitats may look like in the future.
- The Surrey Local Nature Recovery Strategy (LNRS). The Surrey LNRS and Surrey Hills Management Plan (MP) will have a similar programme for engagement and adoption. The Nature section of the Management Plan will need to engage with the conservation bodies which supported the Surrey Hills Making Space for Nature strategy (species and habitat focused), and it would make sense that this aligned to the emerging Surrey LNRS and conversely that the LNRS provided the framework for the Surrey Hills Management Plan Nature section
- **A National Landscape collaborative approach**. There should be the opportunity to develop and share evidence and best practice as part of a National Landscape family, including working with National Park Authorities in the region.
- **Boundary Extension.** Depending on the Natural England boundary review process, it is proposed that the Management Plan considers the proposed Candidate Areas, which will be subject to confirmation from the Secretary of State. This may need to engage new local authorities.
- Participative approach. Working with representative bodies, a cohort of people will be engaged in thinking and challenging what the Surrey Hills will look like given climate change scenarios. This may include a range of site visits with expert advice considering climate change and implications for Nature, Place and People.

# 4. Resources and Budget

4.1 The principle will be for the Surrey Hills Team and partners to integrate opportunities for convening project partners in also helping to develop the Management Plan. Additional budget and resources will need to be identified for the following elements:

- Consultation and engagement events
- Consultancy support, re evidence gathering and VR
- Web platforms
- Design, promotion and publication
